



In compliance with the provisions of BAPEPAM-LK Regulation No. X.K.1, BAPEPAM Chairman's Decision No. Kep-86/PM/1996 dated 24 January 1996 regarding the Disclosure of Information to be made to the public immediately, the Board of Directors of PT Indomobil Sukses Internasional Tbk (the "Company"), hereby inform as follows:

1. In 16 September 2015, PT CSM Corporatama ("PT CSM"), one of subsidiary which 89.61% of its shares indirectly owned by the Company through its subsidiaries, PT Indomobil Multi Jasa Tbk and PT IMG Sejahtera Langgeng, had signed the joint venture agreement, in connection with the plan of establishment of two joint venture companies (joint venture) with Seino Holdings Co., Ltd., Japan ("SHD"), a company in Japan engaged in the business of logistics and transportation.
