dasarkan statistik Otoritas Jasa Keuangan (OJK) per Maret 2016, total kontribusi industri asuransi syariah mencapai Rp2,75 triliun. Realisasi itu bertumbuh 10,29% (on-year/y-o-y). Pada akhir 2015 total kontribusi bruto premi mencapai Rp2,5 triliun.

Ketua Umum Asosiasi Industri Syariah Indonesia (AASI) Marjuniadi mengungkap, asosiasi berharap pertumbuhan kontribusi bruto industri pada kuartal pertama mampu mencapai 20%. AASI berharap perolehan itu mampu tercapai pada kuartal kedua.

► Per Maret 2016, total kontribusi industri asuransi syariah mencapai Rp2,75 triliun.

"Sebenarnya kami di AASI mengharapkan paling tidak pertumbuhan bisa mencapai 20% dalam kuartal pertama ini," ujarnya kepada *Bisnis*, Senin (16/5).

Pihaknya optimistis target pertumbuhan itu mampu terealisasi seiring dengan meningkatnya kinerja asuransi jiwa syariah. Dari realisasi kenaikan produksi 10,29% pada kuartal pertama, kata Taufik, asuransi umum dan reasuransi syariah mengalami kenaikan yang cukup tinggi, yakni di atas 54,76%.

Data OJK juga menunjukkan kontribusi bruto sektor asuransi umum syariah bertumbuh hingga 66,55% (y-o-y) menjadi Rp488 miliar pada akhir kuartal I/2016. Reasuransi syariah meraih pertumbuhan kontribusi 14,12% (y-o-y) menjadi Rp97 miliar.

Pada periode yang sama, perolehan kontribusi bruto sektor asuransi jiwa syariah tercatat Rp2,17 triliun atau tumbuh 2,31% (y-o-y) dari realisasi Maret 2015 yang mencapai Rp2,12 triliun.

OJK mencatat penetrasi industri asuransi syariah pada kuartal I/2016 tumbuh tipis dibandingkan dengan realisasi pada akhir tahun

menilai mesin minumannya sosialisasi dan edukasi terkait dengan industri asuransi syariah menjadi faktor utama yang memicu kurang signifikannya pertumbuhan penetrasi industri.

Dia mengatakan sudah saatnya pelaku industri lebih terbuka dan gencar melaksanakan hal tersebut. "[Pelaku asuransi] syariah harus *speak up*. Sosialisasi dan edukasi publik harus diperkuat."

Terpisah, Direktur Operasional PT AXA Financial Indonesia Faustinus Wirasadi menuturkan perkembangan tingkat penetrasi industri asuransi sangat terkait dengan kinerja industri perbankan. Hal itu pun berlaku pada sektor jasa keuangan syariah. 

PEROLEHAN PREMI

Jastan Incar Pertumbuhan 20%

CARTA — PT Asuransi Jasa Tabak, menargetkan pertumbuhan premi sebesar 20% atau mencapai Rp250 miliar sepanjang 2016. Berdasarkan laporan keuangan yang dipublikasi PT Asuransi Jastan (Jastan) per Desember diketahui pendapatan premi yang berhasil dibukukan 2015 mencapai Rp209,7 miliar meningkat dibandingkan dengan perolehan premi pada 2014 tercatat Rp197,58 miliar. Direktur Utama Jastan Basran optimistis target pertumbuhan premi sebesar 20% pada

tahun ini bisa tercapai lantaran produksi perusahaan pada kuartal pertama tahun ini menunjukkan pertumbuhan dibandingkan dengan periode yang sama tahun lalu.

"Meski ada pertumbuhan, tetapi capaiannya masih di bawah harapan kami," kata Basran belum lama ini.

Dari total pendapatan premi, segmen asuransi kerugian harga benda menjadi kontributor terbesar terhadap total pendapatan premi dengan kontribusi hampir mencapai 50%. Sepanjang tahun

lalu, emiten perusahaan asuransi tersebut juga berhasil membukukan laba bersih sebesar 0,93% dari Rp17,65 miliar menjadi Rp17,83 miliar.

Adapun untuk memacu kinerja perusahaan, kata Basran, pihaknya berharap bisa diikutsertakan dalam konsorsium asuransi tani padi. Saat ini, PT Asuransi Jasa Indonesia (Persero) atau Jasindo ditunjuk sebagai satu-satunya pelaksana program tersebut.

"Kalau ada penawaran pembentukan konsorsium asuransi tani padi, kami sangat berminat.

Apalagi kami juga merupakan salah satu perusahaan asuransi kerugian yang memiliki produk pertanian," ujarnya.

Sebelumnya, Ketua Umum Asosiasi Asuransi Umum Indonesia (AAUI) Yasril A. Rasyid menyatakan pembentukan konsorsium perusahaan asuransi menjadi pilihan yang tepat untuk meningkatkan penetrasi produk asuransi bagi ketahanan pangan nasional tersebut. Pasalnya, konsorsium akan memberikan kemudahan dalam distribusi produk asuransi usaha tani padi. (*Fitri Sartina Dewi*)

In Malaysia, meanwhile, more
than 1,000 inmates are on death row
with no decision yet on whether the
government will abolish the punish-
ment, Nancy Shukri, the Minister in
the Prime Minister's Department,
said.

"As of May 16, statistics from the
Prisons Department show that there
are 1,041 inmates on death row for
mandatory death sentences for of-
fences such as murder, drug traffick-
ing, firearms and kidnap. However,
the sentences have not been carried
out as the cases are still pending ap-
peals with the courts and respective
state's pardons board," she said in a
written reply to a question by Ram-
karpal Singh in Dewan Rakyat Tues-
day. Ramkarpal wanted to know
if the moratorium on mandatory
death sentences was made follow-
ing proposals to abolish the punish-
ment.

Medina swayed voters with a record of surging GDP growth and social
projects that outweighed stubborn poverty, high crime and accusations of
graft in the Caribbean's largest economy. "We have received the support of
the majority of the Dominican people," Medina said in a speech at his cam-
paign headquarters, thanking the nation for his victory.

Final results were still not out more than 24 hours after polls closed on
Sunday night, a situation electoral authorities blamed for tension between
candidates that led to six deaths and unrest in the provinces. Television in
the eastern city of Higüey reported gunfire on Monday afternoon and said
torched tires were still burning at night.


In its latest bulletin, the electoral board said that with votes counted at 67
percent of polling stations, Medina had won 62 percent of the vote, exceed-
ing the 35 percent of his closest rival, Luis Abinader. Abinader has yet to
concede defeat and said he would make his first comments after the election
on Tuesday. The margin is large enough to avoid a runoff, a first for Latin
America's fastest growing economy. — Reuters
