As food stalls around him has closed during the coronaviru outbreak in Singapore, 28-vea old cook Jason Chua has vowed stay open for the many that no depend on him.

The tattoo-covered, forme boxer has been serving up do ens of free meals for those in nee since early April, when the cit state imposed a lockdown aime at curbing virus cases now amor the highest in Asia.

Known as "Beng Who Cooks beng being Singaporean slang fo hooligan, Chua said that the par demic has not been great for bus ness although he is getting by.

"Yes, we are losing, we are no exactly taking salary for a fe months already, but we still d maybe 10 to 25 orders per day for our business side, so that we ca still sustain ourselves throughou this period of time," said Chua. He was inspired to start givin

out free meals after a close frien described his experience of buy ing food for a homeless man. No he's making about 50-60 fre meals a day through a foundation "Beng Who Cares," co-run by hi friend Sean Hung.

Singapore is facing the deepes recession in its 55-year histor compounded by a lockdown du to last until June 1 that has force many businesses to close.

Authorities have also warne that unemployment will likel rise due to these strict contain ment measures and an uncertai economic outlook.

Those requesting free meal mainly low income families, con tact the foundation online vi their Instagram or Facebook pag es to arrange home delivery o collect in person.

Chua said the foundation re fuses to accept donations sinc they believe it "isn't right" fo people to give during curren times of economic hardship, bu there have been a few "forceful donors of cash, oil and rice.

Although it's hard work, Chua a self-described adrenaline junk ie, said his biggest motivation is to hear praise from anyone who en
